Trails To Be Funded For 08-09'

Due to a loud and united message from snowmobilers across the state, the Governor took steps to ensure that snowmobile trails would be funded this season.

Late in the spring, the Office of Budget directed that \$1,000,000 be taken from the snowmobile fund and deposited directly into the general fund. While this move was legal, it was seen as stealing.

Technically the money was not stolen, yet in the eyes of New York snowmobilers it was. Snowmobilers from all over New York and many from outside the state, called, wrote, emailed, and faxed the Governor asking that the funds be restored.

Many state senators signed on to support the push to restore the funds. Dire consequences faced many clubs as costs have risen. The loss of trail funds would close many trails in the coming winter. This in turn would hurt the local economies that depend on snowmobiling as a winter sport.

While the \$1,000,000 will not be returned from the general fund, other sources will instead be used to make up the loss. Over a period of 3 years the money will be coming in. Addtionally more money is being put into New York snowmobiling.

At first this theft of funds looked bad, but it now has turned into a possible victory for snowmobiling in New York State.

Club Youth Program

In an effort to get our youth more involved with snowmobiling at the club level, the Club is asking if there is an interest to have children of family memberships become Snowmobile Trail Stewards.

Snowmobile Trail Stewards, under adult Club member supervision, would take part in many functions of the Club.


