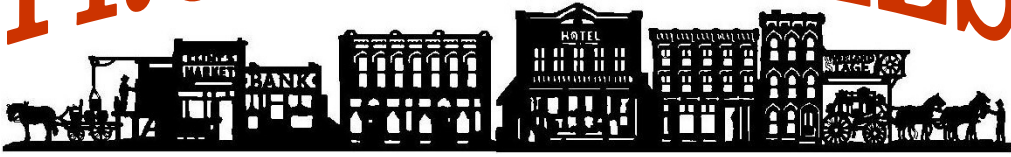

Ice Storm Ushers In New Year

Trails May Be Blocked On December 30th a period of freezing rain coated the Frontier Sno Riders area with a layer of ice. Up to a 1/4" of ice clung to trees limbs and made driving in the Hill Towns very tricky. Power outages effected some of the towns. Within two days the temperature climbed and the ice came off. Rain followed and took away what was left of the snow base from the early December snow storm.

A major cause of concern for snowmobile trails is the damage caused by trees and limbs coming down. Trails will likely be blocked in many places and will require work parties to clear.

Plans are underway to begin the cutting open of the trails. Please watch for requests for help from the Remind App, club website and Face Book page. The ice storm came just as most of the trail system was ready to open for the season.

Snowmobile Safety class in Duanesburg had 28 students signed up. A full class.

MaryAnn Nickloy went to the Schoharie County fire chiefs meeting at the end of November to discuss cooperation for emergency activities.

The NYSSA Snowmobile Map phone App for Apple and Android is available now for \$4.99. It's a location service that even works when you are out of cell service. Tom Rulison says all groomers will have to use it soon. It shows current trail status for the entire state. Plus places for food and fuel.

Landowner mailings were done at the Bauer's, thanks for completing this needed task.

Laudy Hoyenga did a great job building the new drag. It's complete and on the PB100 now. It cost about \$3500 in total as opposed to spending \$10,000 on a new one. A gift certificate was presented to Laudy for his hard work.

Northern Area

Burtonsville/Charleston C7E - Scott Claus/Yancey Zimmer - Zack found a way around Beaver Pond. This was a reroute put in years ago but never used. Up to ice storm, trail was ready for grooming and snow.

Mariaville C7B - Mark VanWoeart - Wind blew down a lot of signs, and then snow covered them, lots of resigning. There are huge ruts in the Mariaville Forest from a 4 wheeler. A re-route now needs to be done. Lots of trees down. Mark will take extra help, signup for Remind.

Sloansville C7F - Laudy Hoyenga - Reroute around Hallenbeck's area, follow signage in Sloansville.

Central Area

Esperance/Delanson C7E - Tom Rulison - Landowner, Marty Hebert, already wants to close his trails because of people riding already. Bridges completed behind Hannaford. Trail now open along the river in village. Still have to use the roads through upper part of village.

Duanesburg C7B/S70 - Dominick Friello - Trees down all over, but signs are all up.

Wright C7B - Joel Church - Cleared many fallen trees. Corn stubble very high between Dr and Webster Rds, stay to field edge to avoid. All signs up, ready for snow and grooming.

Southern Area

Township S70 - Skip Murrell - All signs up, ready for snow and grooming.

Knox C7B - Orvil Bates - Culvert pipe replaced on Turner Road. Still some standing corn on trail.

Maple Inn S73 - Donnie Bauer - All signs up, ready for snow and grooming.

East Berne C7B/S72 - Brian Buchardt - Culvert washouts being addressed in a couple spots, otherwise all signs up, ready for snow and grooming.

Work and grooming logs can now be emailed as Excel forms to Grant Officer Christine Rulison for entry in the Parks trail program, speeding up the process.

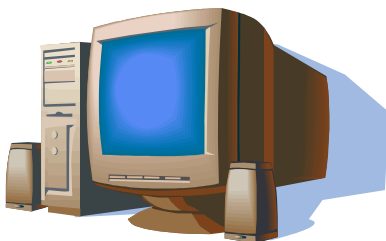
The club newsletter is emailed to the membership each month and is posted on the club website by Webmaster Randy Stein.

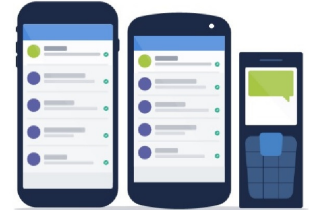

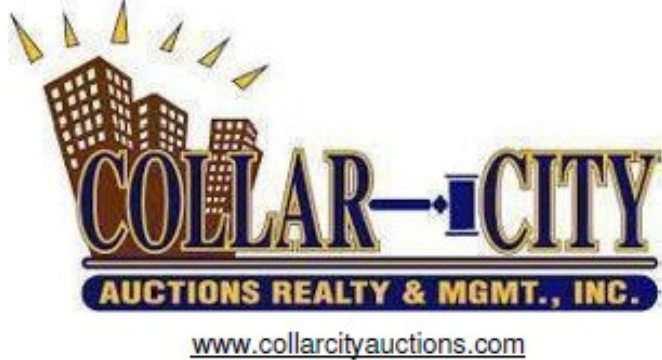
