

C7B Trail Closed

North-South Travel Corridor Severed

Trail C7B from the crossing of Rt 146 southbound to Doctor Road in the Town of Wright, near the Albany/Schoharie County line is closed due to a landowner withdrawing permission.

Illegal use of ATVs was the direct reason for the land closure. The landowner had no issue with allowing snowmobiles to cross their property. The relationship with the landowners had always been one of cooperation. The club thanks the landowners for their past permission.

A reroute was found to keep the trail open. However it would require the use of Webster Road. After a search for a new route, this was the only option to keeping the vital connection open.

This route was not desirable to the club. Roadside riding can be very hard on snowmobiles.

Upon receiving notification from another landowner on January 3rd that their permission would be withdrawn if trail C7B were rerouted onto Webster Road, it was decided the trail would have to be closed.

The trail had been in use for many years.

Closure Impacts

Impact of the C7B trail closure will be far reaching.

No longer will folks be able to ride from Esperance or Duanesburg to places like On The Hill or Maple On the Lake.

Scenic all day journeys to Thacher Park from many points north are now cutoff.

With the Covid-19 lock downs crippling many small businesses over the last 2 years, this trail closure will add hurt to a number as well.

The closure will cause the club to lose grant funding for about 15 miles of trail in both Albany and Schoharie Counties. These grant funds were used to maintain and groom snowmobile trail C7B.

Local riders in the closed area will no longer have the option to ride from home.

Those who choose to ride C7B to the closed section will have to turn around at that point.

Northern Area

Burtonsville/Charleston C7E - Yancey Zimmer - Hughes to Burtonsville Rd signed. Irish Creek bridge in good shape. DEC built new bridge. All signs up.

Mariaville C7B - Mark VanWoeart - Watch speed when riding Tidball to Skyline Dr. Mariaville Peat is in operation, use caution.

Sloansville C7F - Laudy Hoyenga/Brian Schoenherr - New local trail to Diary Carnival off C7F.

Central Area

Esperance/Delanson C7E - Tom Rulison - opened hill to tower above Esperance, was blocked with trees. All signed in area.

Duanesburg C7B/S70 - Open - Rt 20 underpass graded and filled entry to trail. All signs are up. Two short reroutes, one near Schoharie Tpk to avoid construction, other off of Weaver Rd around standing corn, follow signs.

Wright C7B - Joel Church - All signed and cleared to Rt 146. C7B closed between Rt 146 and Dr Rd.

Southern Area

Township S70 - Skip Murrell - Signs are all up. Removed two large trees from trail. Trails still very wet.

Knox C7B - Zach Simeon - Park to Ball Field signed. Permission needed from new landowners. New local trail planned for store in Knox.

Maple Inn S73 - Don Bauer - Most signs are up.

East Berne C7B/S72 - Brian Buchardt - All signs are up including the blind hill.



Closure Continued from page 1 C7B is open from the north down to Rt 146. From the south, the trail is open to Doctor Road, make your turn around before crossing the road.

Maintaining the trail will help local riders gain access at least in one direction.

Grooming may be reduced in the area due to no grant funding for the trail. The section of trail still open will be treated as local trail only.

Parks and Rec will determine where the funding for C7B will end. Usually this occurs from the first junction on either side of the closed section.


What Can I Do To Help?

- The immediate thing you can do to help is to stay off the closed section of trail.
- Next, please notify either the Trail Boss Joel Church or Club President Gerry Lenseth if you know of a possible route to keep this corridor open. Even entirely new areas can be considered. Your personal knowledge or ownership of land for use can be instrumental.
- Influences from outside the snowmobile community have effectively shut down a major corridor in the Frontier Sno Riders trail system. Represent well.
- Please remember the careless acts which occur have their consequences. ATV use on snowmobile trails is only allowed with landowner permission. It is not part of the snowmobile landowner permission agreement.
- All snowmobile riders have a responsibility to follow the rules. They should also report any illegal use of the trails to the authorities.
- Come to the club meeting and find out how you can help reconnect the trail.



Town of Duanesburg Schenectady County Off-Road Law Enforcement:

On Jan. 2, Central Dispatch received a call about vehicles off-roading on Featherstonhaugh State Forest. Forest Ranger Mitchell responded to the area and met with NYSP and the owners of the vehicles. The owners brought the Ranger and Troopers to the vehicles that got stuck on a snowmobile trail. NYSP requested a tow, which required more than three hours of work and a skid steer with a recovery winch to remove the vehicles. Ranger Mitchell issued tickets to both drivers related to motor vehicle use on State lands.
